1 General Fare Increase

2 Vehicle Categories Under 30 Feet

Please comment on the proposed changes to vehicle categories under 30 feet to create a new small car category, extend the length of a standard vehicle, and adjust pricing relationships between vehicle categories.

3 Bicycle Surcharges and Passes

Please comment on the proposal to eliminate the annual bicycle permit and allow passengers paying with monthly passes, multi-ride cards, or ORCA ePurse to bring bicycles without charge.
